## Administrative news

- We have a new Service Manager: Hannah Phillips
- ECMWF are very amenable to an extension of C3S DRS from the end of March to the end of June 2021. ECMWF have said that the extension of the service will be a costed extension, so there will be a modest amount of funding available to cover the maintenance of the service and project management.





## WP1 update

### Main actions this year until now:

- Daily synchronization from C3S DRS to I-DARE,
   in addition to already existing synchronisation in opposite direction
- I-DARE site has been made suitable for use on a mobile phone
- I-DARE projects: 2 new, 16 updated
- Page at I-DARE on C3S-DRS, with also a link to the Metadata Exchange Facility

## WP2 update

1.DC3S311a\_Lot 1.2.4-2019: software for Tools for submitting digitised meta\_datasets to international global data archives – Paul happy with a link to the Lot 1 and Lot 2 portals as proposed in the meeting between Lot 1 and Lot 2 on the 16th July – please can you confirm where we ended up with this? Has anything been actioned yet?

So far me and Simon Noone have successfully tested the Metadata Exchange Facility in sending inventories to Lot 2. We have not yet proceeded with linking software of C3S DRS Portal and Lot 2 Upload Service. May be possible but Lot 2's Peter Thorne doesn't think it's a priority. So we have this tool available by sending inventories from Lot 1's Portal to Lot 2 by e-mail.

2. Contacting user support for editing rights to the metadata is not described in the current user documentation, but this is the path we are currently taking. Paul wonders if a checkbox at registration allowing the user to request editing rights at the start would be better. What is your view on this?

It could be a possibility. What does B-Open think? BOPEN: Needs to be discussed further.







### WP2 update

3.The link to guidelines and templates is on both the metadata inventories page and the metadata exchange facility page. Does it need to be on the inventories page? I know in the emails between ourselves and Paul Berrisford you thought that having the links in two places was good, however Paul advised that there was a meeting with users where there might be some feedback on this, did these users have a preference?

The user that has a preference for this option is me. As I have been adding and editing entries in the inventories, when I add a new entry it's useful to download and see the respective template. But I can concede to removing the guidelines and templates from this page. It's easier for the Portal's maintenance.
